DRIVER SAFETY

- ___ Helmet (Snell K/M/SA 2005 or newer, SFI, FIA)
___ Shoes must be closed-toe and in good condition
___ Seatbelts/harnesses must be in good condition
___ A proper rollbar when it is required
___ Rollbar padding
___ Seats bolted securely
___ Interior and trunk clear of loose items

BRAKES

- ___ Brake pads are less than half-worn
___ Brake fluid is clear. Reservoir is full. DOT 4 recommended
___ Pedal is firm
___ All brake lights are working
___ Master cylinder/calipers are not leaking
___ Rotors are not cracked or discolored

TIRES AND WHEELS

- ___ Adequate tire tread, speed rating, good condition
___ All lug nuts present and torqued
___ Hubcaps removed
___ Wheels - no cracks or structural damage

SUSPENSION AND STEERING

- ___ Wheel bearings - no excessive play
___ Suspension in overall good condition
___ No excessive steering play
___ Shock absorbers - no leakage

ENGINE AND DRIVE TRAIN

- ___ Check all fluid levels, belts, and hoses
Tighten all underhood caps
___ No fluid leaks (oil, fuel, coolant)
___ Battery secured (no bungees)
___ Battery positive terminals covered
___ Overflow containers present and functional
___ Exhaust system functional (may have to satisfy sound restrictions)
___ Throttle has quick, positive return
___ Fuel cap secured

OTHER

- ___ Windshield and rear window are not cracked
___ Windshield wipers function properly
___ Inside & outside rear view mirrors present
___ Car numbers on both sides (vinyl or tape)
